**Agreement for Palermo Ballet Summer Intensive Program Scheduled to be held at Teatro Politeama Garibaldi Practice Facilities from July 23rd to August 30th, 2018**

**Hold Harmless Agreement**

1) I acknowledge that dance is a physical activity and recognize the possibility of injury associated with any physical activity and hereby inform Palermo Ballet Summer Intensive organizers that Dancer is current with physical examinations by personal physician(s) and is physically qualified to participate in a dance program. There is no known physical condition which would interfere with dancer participation in this program. I also agree to release, discharge, indemnify and hold harmless Palermo Ballet Summer Intensive, its affiliated organizations, employees, teachers, staff, volunteers, and associated members from any and all claims by and on behalf of the dancer that might arise by dancer participation in this dance program. I understand that in order to be allowed to participate Dancer must carry health insurance that is provided by family, self, employer, or state or federal health insurance carrier.

2) Palermo Ballet Summer Intensive and its instructors are not liable for loss of or damage to student’s personal property.
